## **NOTES TO CLERGY FOR COMPLETING THIS FORM**

When the number of applications to Chalfont St Peter Church of England Academy exceeds the number of places available, governors will award places in accordance with published criteria. You will probably be aware that three of these criteria relate to church attendance. In order to ensure that the published criteria are applied fairly, governors are required to have evidence supplied by an appropriate clergyman to confirm church attendance **of a parent or guardian**. You are therefore asked to complete this form because the applicant is claiming to fulfill one of the following criteria:

### **CRITERION 7 – Children of families living out of catchment, who worship at the Parish Churches of Chalfont St Peter. (See note i)**

One of the parents / guardians has attended church regularly (at least twice a month on average) for a minimum of two years immediately preceding the date on the Supplementary Information Form.

### **CRITERION 8 – Children of families living in contiguous parishes who worship at Anglican churches outside the Parish of Chalfont St Peter. (See note i)**

One of the parents / guardians has attended church regularly (at least twice a month on average) for a minimum of two years immediately preceding the date on the Supplementary Information Form.

### **CRITERION 9: Children of families living in contiguous parishes who worship at other churches in the Parish of Chalfont St Peter. (See note i)**

One of the parents / guardians has attended church regularly (at least twice a month on average) for a minimum of two years immediately preceding the date on the Supplementary Information Form.

In the event that during the period specified for attendance at worship the church has been closed for public worship and has not provided alternative premises for that worship, the requirements of these admission arrangements in relation to attendance will only apply to the period when the church or alternative premises have been available for public worship.

**Note i** - Parent is defined in law (The Education Act 1996) as either:

- Any person who has 'parental responsibility' (defined in the Children Act 1989) for the child or young person OR
- Any person who has care of the child or young person
